EDUCATIONAL OPPORTUNITIES ARE CATERED TO SPECIFIC POPULATIONS AND PROVIDE PROPER INFORMATION RELATED TO SEIZURE RECOGNITION AND FIRST-AID. THESE EDUCATIONAL OPPORTUNITIES ARE PERFECT FOR LAW ENFORCEMENT AND ALL FIRST-RESPONDERS, DAY CARE EMPLOYEES, COMMUNITY FOCUSED ORGANIZATIONS, AND ANY BUSINESSES THAT MAY WANT TO LEARN ABOUT EPILEPSY. APPROXIMATELY 10,962 INDIVIDUALS WERE IMPACTED BY THE EDUCATION/TRAINING PROGRAM IN THE 2020 FISCAL YEAR. THE MEDICATION ASSISTANCE PROGRAM WAS SPECIFICALLY CREATED TO HELP INDIVIDUALS WITH EPILEPSY, WHO LIVE AT OR BELOW THE U.S. FEDERAL POVERTY LINE, WITH PURCHASING THEIR MEDICATION. EACH CLIENT WHO ENROLLS IN THIS PROGRAM IS ELIGIBLE FOR AN ANNUAL STIPEND OF \$400 WHICH CAN BE USED AT THEIR DISCRETION. 76 INDIVIDUALS WERE ASSISTED DURING THE 2020 FISCAL YEAR. STUDIO E ART THERAPY IS A MULTI-WEEK ART PROGRAM THAT GIVES CHILDREN, AGES 6-17, WITH EPILEPSY, THE OPPORTUNITY TO CREATIVELY EXPRESS THEMSELVES THROUGH ART AND ALSO CREATE A COMMUNITY OF SUPPORT AMONG THEIR PEERS. 35 CHILDREN WERE PART OF THE ART
