STUDIO E ART THERAPY IS A MULTI-WEEK ART PROGRAM THAT GIVES CHILDREN, AGES 6-17, WITH EPILEPSY, THE OPPORTUNITY TO CREATIVELY EXPRESS THEMSELVES THROUGH ART AND ALSO CREATE A COMMUNITY OF SUPPORT AMONG THEIR PEERS. 35 CHILDREN WERE PART OF THE ART PROGRAM DURING THE 2021-2022 FISCAL YEAR. DURING THE SUMMER WE HOSTED A PHOTOGRAPHY CAMP FOR CHILDREN IMPACTED BY EPILEPSY. THIS IS A 4-WEEK PROGRAM WHERE CHILDREN ARE GIVEN AN OPPORTUNITY TO EXPRESS THEMSELVES THROUGH PHOTOGRAPHY, WHILE ALSO LEARNING PHOTOGRAPHY AND CAMERA SKILLS. IN THE 2022-2023 FISCAL YEAR, 35 CHILDREN ATTENDED OVER THE 4-WEEK PERIOD. EACH MONTH EFSETN HOSTS OUR CONNECTIONS SUPPORT GROUP MEETINGS FOR ANYONE WHO IS IMPACTED BY EPILEPSY. THESE MEETINGS ARE A GREAT PLACE TO CONNECT WITH OTHER PEOPLE WHO UNDERSTAND WHAT YOU'RE GOING THOUGH AS WELL AS EXPERT GUESTS FROM A WIDE VARIETY OF FIELDS.
